RULES:

Entrants must be 2023-2024 members of the USBC Youth.

1. ENTERING AVERAGE as follows:

A. Highest 2022-23 USBC league average based on a minimum of 12 games (Bowl.com). If none, go to B.

A. Current average of 12 games (Fall/Winter) or more (bring or mail w/entry standing sheet). If none, bowler will bowl scratch.

Rule # 319A Item #2 is waived for this tournament, no re-rating.

2. Handicap will be 90% of 220 for all eligible bowlers.

3. Late bowlers will start scoring in the frame in progress upon their arrival, receiving zero for any missed frames.

FALSIFICATION OF AVERAGE MAY RESULT IN THE DISQUALIFICATION OF BOWLER.

4. Bowlers must report to the lanes at least 30 minutes & walk-ins 1 hour prior to bowling.

5. Dry towels and shammy's are only allowed in the bowler's area during the duration of the tournament.

ALTERING THE SURFACE OF A BOWLING BALL BY USE OF ABRASIVES, CLEANERS AND/OR POLISHES IS PROHIBITED

6. During competition including warm up prior to your squad, no substance maybe placed on the outer surface of the bowling ball.

7. No modifications can be made to affect the balance of the ball once competition has begun (1st frame of first game).

PENALTY:

1ST OFFENSE: WARNING

2ND OFFENSE: DISQUALIFICATION.

Any protest regarding scores or eligibility shall be made to the tournament director within 72 hours.

TOURNAMENT DIRECTORS' DECISION IS FINAL UNLESS AN APPEAL TO USBC IS FILED.

NO REFUNDS WILL BE MADE ONCE THE ENTRY HAS BEEN PROCESSED.

8. ATTIRE:

-No halters or tank tops or head apparel (with the exemption of ear buds). No profanity on clothing.

-Shorts, skorts, or skirts must be longer than the end of your fingertips when placed by your side. All pants will be worn at waist level with no underwear or bare skin showing. Holes (torn or purchased) in clothing is not allowed.

-The Tournament Director will have the right to ask any bowler to change their clothing or equipment.

-If the bowler refuses, he or she will not be permitted to bowl, and the entry fee will be forfeited.
